Planning Chair report - Doug Altman (KEOSI)

Boulder County plans to go to level 'clear' on May 16 which opens up a number of possibilities for Club activities.

The main item for discussion Wednesday is the ARRL Field Day. What do you think we should do? I list three options. Option 1 costs us about \$100 (we get a very significant discount from the city for our event). Option 2 \$60.

June 26th and 27th ARRL Field Day

ARRL same rules as last year plus ... Club members can operate from their home location using house power, or be mobile, or portable.

Options:

- 1) Reserve Izack Walton Pavilion on Sunset. Set up two stations. Have operator schedule. The city needs to know if we want to reserve the Pavilion (entire park) indoors and out. For both days or just one day. AF4BY is willing to stay all night again, to eat, sleep and operate the radio. I will not use the Spiderbeam this year. It takes 6 people one hour to set up and to take down. We could have two or three wire antennas. Maybe buy a couple of mini G5RV antennas to use.
- 2) Hold out doors, Izack Walton park on Sunset, on Saturday only. Two stations. Easy to put up antennas.
- 3) Operate from home like last year, and turn in logs with individual call sign, and affiliation with LARC.

The Board approved option 1, including the \$100 rental fee to the City of Longmont.

August 7th --- Fair Parade. I was told there will be a parade, even if there is no Fair.

August 14th --- LARC annual - Radio in the Park. Thompson park pavilion. 11am till 5pm. If Boulder County goes Covid Clear level, we should be able to do this.

August 21st ----- Triathlon ------ The city has it on the public schedule, and is taking registrations. I have called the city planner for this event to get more details. The Club will not participate in the Triathlon.

October 30th Saturday, 10 am --- Halloween Parade. The city would like us there.

November 13th Saturday --- Turkey Trot foot race. The city would like us to be there. Same location as in prior years, Altona School.

December 8th or 15th -- LARC Christmas Dinner. Doug will look into the Niwot Grange, and plan on having the event, pending the pandemic. Chuck will look into Terry Street as an alternative venue.

December 11 – Parade of Lights.

Chuck proposed another event which would be removing some equipment from the 350 Terry Street facility. This would occur in June.

<u>Technical Chair report – Mark Skelton (N7CTM)</u>

Mark wants to replace some Cat 5 cables in the repeater installation. The cost would be \$250 for improvements. The motion was approved by the Board.

 - b. Said he'd be happy to present at any club meetings (online or in person)
