# LARC Board Meeting Report from Education Team

#### Recent Class

 We just finished teaching a General Class on 03/23/19, which was our second class for 2019. Although 11 people registered, only 10 showed up, one dropped halfway through, and 9 completed the class. Two did not show up for the test session on the 23<sup>rd</sup>. This class was extended by a week due to 3 cancelled classes from snow.

### • Upcoming Class

• We have a new Technician License Preparation Class starting later this month (April), with the starting date tbd. There are currently five registered students, but more are expected to register soon after we announce it.

### • VE Exam Session

Our General Class VE Exam Session on 03/23/19 went well. 18 people came for their test, including 9 of our Technician Class students and 9 walk-ins, and all but one passed their exams they came for. Three of the people (2 of whom were students) who weren't yet licensed also upgraded to their Extra class license, taking all three tests at the session and passing them all with near-perfect scores. One person from Laramie drove in to upgrade to an Amateur Extra license and passed his upgrade exam as well.

## • Upcoming VE Exams

- We have a LARC VE Exam Session set for Saturday, 04/06/19, at 9:30 am at our LARCFest in the Clover Building.
- Our next regularly-scheduled LARC VE Exam Session is at the end of April on the 27<sup>th</sup> at 10:00 am at the Niwot Fire Station.
- We may be holding another one at the end of our Technician Class, if it doesn't end by the exam session on the 27<sup>th</sup>.

## • Financial

• From our recent General class, we generated \$395 in tuition and book sales (minus \$50 for student snack fees), providing \$345 for the Club. We also turned in \$80 with four new student membership applications.
